I UNDERSTAND AND ACKNOWLEDGE THAT ROCK CLIMBING ACTIVITIES HAVE INHERENT DANGERS THAT NO AMOUNT OF CARE, CAUTION, INSTRUCTION, OR EXPERTISE CAN ELIMINATE AND I EXPRESSLY AND VOLUNTARILY ASSUME ALL RISK OF PERSONAL INJURY OR DEATH, WHETHER FORSEEABLE OR NOT, SUSTAINED IN CONNECTION WITH PARTICIPATION ON IROCK climbing wall.

Accordingly, under no circumstances will I nor any of my heirs, distributees, guardians, legal representatives and assigns present or bring any claim for personal injury, property damage, or wrongful death against: Total Fitness Center Inc, DBA IROCK, and any or their subsidiary companies (hereinafter "RELEASEES") or any officer, director, member, agent, servant or employee of RELEASEES based upon RELEASEES negligent acts or omissions.

I, individually, and/or on behalf of the minor participant listed below, also hereby agree to a blanket event release of all rights related to my audio and photographic image that may arise out of my participation in activities on or around the IROCK climbing wall. I understand that this event release includes any and all marketing, promotion or advertising specific to any event that may occur anywhere and anytime on any media as later used by RELEASEES or any of their representatives or assigns.

The RELEASE shall be construed and enforced in accordance with the laws of the State of Utah. Any action at law, suit in equity, or other jurisdictional proceeding arising in connection with this Agreement or my participation on the IROCK climbing wall, shall be instituted only in the courts of Weber County, Utah.

ROCK CLIMBING RULES

1. All climbers must sign a release form before using the facility.
2. Anyone under 18 must have a parent or guardian sign their waiver.
3. All climbers ages 12 to 15 must be belayed or spotted by an adult.
4. All children under the age of 12 must be belayed by a parent/guardian.
5. All climbers must demonstrate proper tie-in the figure 8 knot.
6. Climbers and belayers must perform safety check
7. Lead climbers must pass lead certification test before lead climbing.
8. Participants must pass the top rope certification test before belaying anyone.
9. All personal climbing equipment must be inspected by a staff member prior to use in iROCK.
10. Chalk balls are required. No loose chalk please.
11. Stand clear of other climber's fall or swing zones unless belaying or spotting.
12. All those bouldering must have an accompanying spotter.
13. Please be courteous, kind, and respectful of others while at iROCK.
14. Please comply with any request or instruction given by the iROCK staff.
15. Shirts and shoes are required at all times.
16. No jumping off boulders (climb down).
